

Promotion Addendum – San Bernardino County (SBC) Fair

This Addendum (“Promotion Addendum”) to the Master Official Rules - Alaska USA, Promotions, Sweepstakes, and Giveaways (“Master Official Rules”) describes certain rules specific to the **SBC Fair 2022 Giveaway** Promotion and incorporates the Master Official Rules by reference. **THIS ADDENDUM DOES NOT CONTAIN ALL OF THE RULES APPLICABLE TO THIS PROMOTION. TO REVIEW ALL APPLICABLE RULES, READ THIS ADDENDUM TOGETHER WITH THE MASTER OFFICIAL RULES.** If there is a conflict between the Master Official Rules and the rules described in this Promotion Addendum, this Promotion Addendum shall control. Capitalized terms not defined herein shall have the meaning attributed to them in the Master Official Rules.

Eligibility. The Promotion is open to anyone who meets the eligibility requirements outlined in the Master Official Rules, and who submits a complete entry form during the Promotional Period as outlined below. Limit of 1 entry per person. This is an Alaska USA promotion and not sponsored by or associated in any way with the SBC Fair.

Promotional Period. SBC Fair Giveaway Promotion runs from 2:00 PM PDT, May 28, 2022 — 10:00 PM PDT, May 28, 2022 (“Promotional Period”).

To Enter. Submit one entry form during the Promotional Period, complete with first and last name, phone number, and email address: 1) by hardcopy entry form available at the Alaska USA SBC Fair booth, or electronically through the SBC Fair giveaway landing page (<https://event.alaskausa.org/sbc>) accessible via QR code on the giveaway poster at the Alaska USA booth, or 2) regardless of SBC Fair attendance, electronically at <https://event.alaskausa.org/sbc>.

Alternate Method of Entry. Regardless of SBC Fair attendance and as an alternative to the methods of entry noted above, submit an online entry form at <https://event.alaskausa.org/sbc>.

Selection of Winners. An Excel sheet of all eligible entries received during the Promotional Period will be created. On May 31, 2022, a random number will be generated and the entry associated with that number will be the Selected Entrant.

Odds: Estimated odds of winning are dependent upon the number of eligible participants that enter.

Prize(s): One \$200 Visa Gift Card Valued at \$200.00.

Notification of Winners. Sponsor will notify the Selected Entrant by email or phone between 8:00 AM and 5:00 PM PDT on Tuesday, May 31, 2022. The Selected Entrant must respond to Sponsor’s notification message by 5:00 PM PDT on Wednesday, June 1, 2022, to acknowledge receipt or the Selected Entrant will forfeit the opportunity to be verified as a winner and Sponsor will repeat the selection process outlined above after removing the first Selected Entrant’s entry to select an alternate Selected Entrant. Sponsor will arrange for pick up or shipment of prize upon winner’s response to notification.
